OPPAGA: Organization and Work

- OPPAGA is a non-partisan joint legislative unit, conducting research for both the House and Senate.
- OPPAGA is assigned projects in three ways.

Law (legislation or budget proviso)

House or Senate leadership approval of member or committee/staff request

Joint Legislative Auditing Committee (JLAC)

Performance Reviews

<u>Research team</u>: OPPAGA may conduct or contract for performance reviews of conservation districts.

Performance reviews generally focus on:

- Specific statutory criteria
- Efficiency of operations
- Effectiveness of activities
- Accountability and transparency
- Significance of findings

Research Objectives

What information will the research team review?

Statutory Research Objectives


The performance reviews will include three previous fiscal years and the current fiscal year's information on:

- 1. Creation, governance, and responsibilities of the district
- 2. The district's purpose, goals, and objectives
- 3. District performance relative to goals and objectives
- 4. District resource management (money, facilities, equipment, and staff) and planning
- 5. Service delivery and potential for duplication

Governance

What is known about the creation of the district and its governance?



Goals and Objectives

What is the purpose of each program and activity?

Problems or needs that the program or activity was designed to address

Expected benefits

Achievable in adopted budget

Performance

Assess whether the district's goals and objectives have been achieved, are measurable, and address the district's purpose.

Internal

If the district has performance measures, are these:

- Being met
- Useful to evaluating the district
- Sufficient to evaluate costs

External

What data is available on how external stakeholders evaluate the district's performance:

- Surveys of residents
- Post-service evaluation forms
- Grant application feedback


Resource Management

How well does the district manage its resources?

Costs: administrative, program, contracting	Specific expenditures: staffing, facilities, equipment	Trends: revenues and expenditures
Cost reduction efforts	Strategic plans	Previous financial audit findings

Services and Duplication

How does the district deliver services and are similar services locally available?



Recommendations

GOALS

- Improve operations
- Reduce costs
- Reduce duplication

CONTENT

- Condition or problem
- Criteria specifying how the program or activity should operate
- Cause of the problem
- Implications

LEVEL


- General: germane to all districts
- Specific: particular to one district
- A state or local government agency
- The Legislature

Recommendations will include potential benefits and adverse consequences of a change.

Process Overview



Typical Fieldwork Activities

Fieldwork will begin with the district. The research team will need a point of contact for all correspondence.



Managing Information Requests

It is not all about you.

The team will obtain information from external sources if referred or if they are more appropriate.

Do not reinvent the wheel.

 If information is online or in an existing document, refer the team to that.

Pause before sending sensitive data.



Preliminary and Tentative Draft Review

Once fieldwork is over, districts and legislative committee staff will receive draft reports.
